### **Councillor Reports**

#### Councillor LePoidevin

 Attended the Premier John Horgan meet and greet and was fortunate to have a few minutes conversation with him.

#### Councillor Fennema

- Attended the budget meeting on January 16<sup>th</sup>. She extended appreciation to Director of Finance Laura McMaster for all the work put into preparing the proposed budget and answering any questions posed to her with ease. Councillor Fennema was pleased with how much had been accomplished at this meeting.
- Attended Premier Horgan's visit on January 18<sup>th</sup>. Although the visit was short, she
  appreciated the efforts to make the visit happen smoothly. Councillor Fennema had a
  couple of people say once the event was cancelled people assumed the Premier wasn't
  coming. Others felt there should have been a way to present questions from the public
  to have answered by the Premier.

Mayor Storey replied that she would be meeting with the Premier again and if members of the community sent her their questions, she would be able to forward them the Premier when they meet.

 Attended the Autumn Services meeting on Monday, January 20<sup>th</sup>. They received a \$10,000.00 grant from Integris Credit Union for new tables and chairs. Autumn Services has also recently purchased new kitchen equipment.

#### Discussion.

### Mayor Storey

- was interviewed by a consulting group hired by the Bulkley Nechako to do a Skills Cap
  Analysis regarding barrier and gaps with jobs and lack of employment in Fraser Lake.
  The conversation included possibilities to help shift job opportunities in the community.
  There is a survey online for information gathering on jobs, or lack-of, in Fraser Lake and area.
- Mayor Storey shared how preparing for the Premier's meeting was an interesting leadup with lots of work involved getting ready for the visit. The meeting was short and

didn't include an infrastructure conversation, but she felt it was important for the Premier to see how close the fires came to our community. She also felt the relationship building with the Premier went well and she looks forward to a continuing conversation with him. Fraser Lake was fortunate to have a meet and greet with the Premier, an opportunity not offered in most communities. Mayor Storey shared appreciation of help to set up and prepare for the afternoon and a few highlights of the Premier's visit with council.

#### Discussion.

- Mayor Storey is attending the Resource Forum on behalf of Nadleh Whut'en who invited her to attend as their guest. During that week she was invited by Chief Larry Nooski to attend the Pathways Agreement signing with Carrier Sekani and the seven first nation communities.
- Mayor Storey hopes to connect with MLA John Rustad at the Resource Forum.
- Mayor Storey and CAO Holland had a meeting with Chief Archie Patrick, Chief Larry Nooski and R. Radloff & Associates about the line to connect sewage from Stellat'en to Nadleh. The concern with the project is that the Village would still have to maintain their own system and the others as well. The issue is how much it will cost the Village to get the system up and going. If the Village applies for the grant subsidy it will get a 75% discount for Municipalities; but if Nadleh Whut'en and Stellat'en First Nation apply they receive a 90% discount for First Nations. The win/win would be if the First Nations applied first for the grant subsidy which would give the Village the extra 15% bonus. No decisions have been made to bring to council at this time.
- Mayor Storey received a phone call from Cindy Shelford, NKDF, there's a coalition of the Lakes TSA (Timber Supply Analysis) and they've invited us to the table. Only two coalitions have been approved, this is the third one. There will only be three coalitions approved in BC for the province to fight for forestry resources to come up with plans and solutions.

#### **Business from the CAO**

#### Council Remunerations:

CAO Holland had information for council about the remuneration paid from the Village and for comparison remuneration paid to council from communities from the Okanagan up of similar and larger size.

Canada Summer Jobs – Student Summer Program Employment Funding: The Student Summer Employment Funding has been used for fifty percent (50%) subsidy on minimum wage for (4) high school students and (4) university students for Capital projects.

In the past the Village of Fraser Lake has applied for four university student positions (16 weeks) and four high school student positions (9 weeks). Seven of these students are employed with the Public Works Department and one student position in the Municipal Office. The Village budgets annually for summer students.

Discussion was prompted about the next Budget meeting date before the end of February. Two dates were chosen, and Mayor Storey offered to contact everyone via email to decide which one worked best overall.

### **Bobcat Repairs**

Mayor Storey mentioned she and CAO Holland had a discussion regarding a plan for moving snow on the lake and putting together guidelines for staff to abide by while doing work on the ice with equipment.

## Ice Plant - Cold Weather Policy

The Cold Weather Policy used to be a -40 shut down of the arena, should it still be this way? CAO Holland believes it's important to have someone in the arena at this temperature as well to make sure everything continues to run smoothly during extreme cold weather and for early detection of a possible problem.

Director of Public Works, Vern Hilman presented an expenditure overview for the existing ice plant; possibilities of repairs and consideration of a switch over from the existing ice plant to an ammonia-based plant; and a cost analysis of each.
