Reports on Council Activities:

Councillor LePoidevin

Councillor LePoidevin attended the All-Candidates Forum on September 27th.

Councillor Jenkinson

Councillor Jenkinson served at the pancake breakfast, spent some time with the hostages and attended the July 1 festivities. Yesterday he was able to speak with the VP of BC Ambulance to discuss the future of BC Ambulance in Fraser Lake. He was asked to provide a letter about this station and the conversation went very well.

Councillor Fennema

Councillor Fennema met with Mayor Storey and MP Taylor Bachrach on August 28th. She was able to advocate for the cleanup of the CN Yard in Fraser Lake. They took MP Bachrach to the Fraser Lake CN Yard and then to the airport to show him how bumpy the road was and not ideal for medical transport.

Councillor Fennema attended UBCM September 12-16, had meetings with several ministers, and it was a very busy week.

She attended the Historical Society meeting. They have requested the 2-night maximum stay at the White Swan Municipal Campground be increased to 4 nights.

Mayor Storey

Mayor Storey attended the Regional District of the Bulkley Nechako (RDBN) board meeting. There were discussions on possible transfer station operations. User or dump fees is an option, there was a lot of discussion around how that system would look. There are issues with the current volume of trash and limited amount of diversion for recycling. The RDBN is one of the last Regional Districts without a tipping fee. There were other discussions on having recycling at the transfer stations, users could drop off their recycling then get weighed. Illegal dumping is an issue, and they are working on a strategy for this.

A brief discussion followed.

Mayor Storey met with Councillor Fennema and MP Taylor Bachrach on August 28th. She toured MP. Bachrach to the Fraser Lake CN Yard and then to the airport. She is hoping this will help get the CN Yard mess cleaned up.

Mayor Storey attended UBCM and it was a very busy week, she could not have done it without Councillor Fennema and CAO Holland. She was able to attend the Truck Loggers Dinner, met with MLA Kevin Falcon who is the leader of the Liberal Party and attended the Resource Benefit Alliance (RBA) signing of the Memorandum of Understanding. Minister meetings were great. They discussed trying to expand the Community Forest, healthcare, seniors living and assisted living, BC Ambulance Service about a medi-vac helipad and subsidized childcare. She also attended the Hydrogen symposium and found it very interesting. Mayor Storey was

able to meet with Cathy Ulrich (CEO of Northern Health) and was told a medi-vac helipad would have to be at least 50' x 50', heated and with lights. The Fraser Lake Clinic is next on the list for upgrades.

Councillor Jenkinson mentioned to be cautious about how close to the clinic a helipad should be. BCEHS is looking at medi-vac patient transfers via helicopter vs. ground ambulance. The closer to the clinic the better.

Mayor Storey attended the Community Transition Meeting regarding the Fraser Lake Sawmills shift curtailment. Currently West Fraser is saying 60 layoffs will occur rather than the 77 initially thought. 24 employees have expressed interest in the bridging program, but most likely that number will be around 16. 30 Fraser Lake residents could be laid off.

She attended the BC Council of Forest Industries (COFI) dinner on September 22nd and met the COFI president.

Mayor Storey mentioned the Northern Development Initiative Trust (NDIT) labour study has been released. She mentioned the Village should use the Northern Healthy Communities Fund to fund new employees.

Mayor Storey attended the Northern Health (NIRD) meeting on September 27th. The discussion was around Virtual Walk-in Clinics. She expects this might be coming to Fraser Lake soon but is unsure how this program is working in other areas.

Sewer Pump Failure:

A full-sized tea towel was flushed down a toilet and ended up in the flygt pump of Lift Station #1. The large piece of cloth seized the flygt pump, which in turn burned out the motor. Replacement of the damaged motor is \$15,391.04. Delivery of the new pump is anticipated in 4 to 6 weeks.

Staff recommend to expend this cost from the Northern Capital and Planning Grant reserve. The NCPG Reserve holds a balance of \$1.7 M.

Councillor Fennema asked if the Kin Park washrooms were closed for the

Mayor Storey mentioned the Drone project closing ceremonies are being held on October 5th, 10 am at the White Swan Park Drone location. She is unsure if she can attend and asked if someone from Council could attend and say a few closing words.

Mayor Storey has received several complaints about barking dogs. The complainants have families. Dogs are barking all day and night. The complainants are upset at the dog owners for not addressing the problem. Fire Chief Pacheco has been attending these complaints and is doing what he can, but we do not have a fine system in place.

CAO Holland commented the Village does not have a municipal bylaw ticketing system. The Village has the Good Neighbour Bylaw which is a compliance bylaw. Moving to a ticketing system is expensive to manage. Municipal tickets require the hiring of a lawyer to prosecute. Typically, they do not hold up well in court when a ticket is contested. However, this could be a future consideration.
