Council has asked Admin to bring back more information on Cheque # 27577 for Seal Tec Industries Ltd. Council would like to express their feeling of concern that the job is not up to standards, and is enquiring if the seal coating is finished or if there is more work to be done? Will Seal Tec Industries be putting in more tar and gravel on the patched area? Councillor LePoidevin stated he had talked to Public Works Director, Vern Hilman who told him the crack sealing was complete. Mayor Lindstrom is not impressed with the patch job. Council is wondering if this was a "test" patch job? If so, it has failed, and Council would not like to see this done again in the future. Council noted that Francois Lake Road was not very nice when it was first seal coated; however, it improved after a lot of traffic. Council is hopeful the seal coating will smooth out as well.

Cannabis update

Minor Hockey - Hard Surface

With the replacement of the Ice Plant Condenser this fall, the availability of the arena ice will be late; probably November 14, 2018. Minor Hockey would like to run dry land training activities on the Hard Surface of the Arena from the beginning of October until mid November. They have proposed dry land training on Tuesday and Thursday evenings for three hours per evening. The Hard Surface cost is \$25 per hour. Do these circumstances deserve a reduced rate? Should the Village provide an incentive to conduct training in Fraser Lake? Will that keep our minor hockey players in Fraser Lake?

Mayor Lindstrom thinks it is a good idea to let Minor Hockey use the hard surface. Mayor Lindstrom would like to help Minor Hockey because he feels they have been suffering.

Laura told Mayor and Council that administration does not have the right to waive fees without Council approval.

Councillor LePoidevin pointed out that Pickleball has been on the Hard Surface three days a week, three hours per night, and has not been charged as it is a community event. Councillor LePoidevin feels that if fees are to be imposed, it must be fair to each group. If there is a fee for one group, there should be a fee for all groups.

Councillor Reyden asked if the Recreation Director was running Pickleball.

Councillor LePoidevin stated that Pickleball is run by Dave Samson and Gary Webb. Councillor LePoidevin said that the Village owns 3 nets, and he owns one net, but in his mind Pickleball is completely run by two individuals, not the Village of Fraser Lake recreation.
