## **Delegation:**

Invasive plants are non-native plants to the area. They pose a problem because they tend to push out the native species. They are more than just the commonly known Noxious Weeds (these are listed in the Weed Control Act). The Noxious Weed list is what land managers are required to control. Some of the characteristics of invasive plants are: they grow rapidly, they are very prolific and there are no natural controls. They love disturbed soils and can out compete native species. Some invasive plants can co-exist with out too many negative impacts. An example is dandelions.

Invasive plants have an environmental impact. They can put the ecosystem at risk and potentially even destroy it if the non-native plant is very aggressive. An example is the Japanese nock weed which was brought over to act as a bank stabilizer. The root system did not hold the dirt. Instead the root broke off and the nock weed spread quickly. Invasive monocultures threaten the productivity of the land. The economic impact on utilities, transportation, recreation and tourism to eradicate these plants is costly. Invasive plants can cause a loss of biodiversity. You can lose the birds, insects and even the micro – bacteria in the soil (some non-

native plants will poison the ground) so native plants cannot grow. Some of these non-native plants may also pose a threat or concern to human and animal health.

Plant Councils are in place to actively control these plants. The Invasive Species Council of BC is in responsible for the outreach of information and materials and to act as a liaison. This provincial organization is divided into regional areas. The Northwest Invasive Pant Council consist of the Fraser Fort George Regional Districts, the Bulkley Nechako Regional District, the Kitimat Stikine Regional District, the Skeena Queen Charlotte Regional and the Stikine. NWIPC currently has 23 funding partners — including various Regional Districts, Municipalities, First Nations, the Province, various industries and Agricultural associations. The NWIPC is a non-profit society with a board of directors; they have contracts with 8 invasive plant managers and staff to meet the day to day needs of the council. They primarily coordinate and deliver an integrated program. This program treats invasive pants regardless of the jurisdiction they are located in. They provide education and awareness to the public with a focus on prevention.

Treatment for non-native plants is primarily mechanical and herbicides. Mayor Lindstrom ask what the impact herbicides have on the Honey Bees. Mr. Hill explained that they use herbicides which are non-carcinogenic not pesticides or insecticides. They collaborate with local area Bee Keepers; they manage the plants either before flowering or after flowering; not during. Councillor Storey asked about the Honey-nut Cheerios Ad campaign for wild flower seed mix. Mr Hill responded that – the mix is safe for our area.

NGLGA phoned Councillor Storey to follow up on the idea for newly elected mentorship program. The idea is that newly elected officials can learn from someone with experience.

Community Volunteer Banquet cannot be held in April. There is not enough time to properly organize the event. The tentative date will be September 15, 2017.

Mayor Lindstrom –Attended COFI last week. Mayor Lindstrom spoke with Minister Thompson briefly about the Community Forrest application. There is not expected to be any announcements until after the May 9<sup>th</sup> election.
