COUNCIL COMPENSATION AND ALLOWANCE BYLAW**

A bylaw to set out annual compensation and allowance schedules for members of the Village of Fraser Lake Municipal Council

WHEREAS, the Council may, by bylaw, provide an annual stipend and meeting allowance out of annual revenue to the members of the Municipal Council of the Village of Fraser Lake.

WHEREAS, the Council may, by bylaw, set out an annual travel and expense allowance for the Mayor and members of the Municipal Council of the Village of Fraser Lake.

NOW THEREFORE, the Council of the Village of Fraser Lake in open meeting assembled, enacts as follows:

Definitions:

Annual remuneration Period means from January 1, 2023, until the end to term;

Council means the Municipal Council of the Village of Fraser Lake.

Council Members means the Mayor and Councillors of the Municipal Council of the Village of Fraser Lake.

Compensation for Council Members:

1. An annual stipend shall be paid to members of the Municipal Council out of the annual revenue of the Village of Fraser Lake:
2. To the Mayor, \$21,094.36, for the annual remuneration period beginning January 1, 2023.
3. To each Councillor, \$11,664.20 for the annual remuneration period beginning January 1, 2023.

Adjustment for inflation – Cost of Living Allowance:

The annual stipend paid to members of the Municipal Council will be adjusted upward to offset the impacts of inflation by way of a Cost-of-Living Allowance. On January 1, 2023, the annual stipend for members of the Village of Fraser Lake Council will be adjusted upward by four (4) percent based on the *Consumer Price Index* and a resolution of Council. every year after that the adjustment for inflation will be two (2) percent unless otherwise adjusted by Council by way of a resolution.

Meeting allowances:

The meeting allowance paid to the members of the Municipal Council out of the annual revenue of the Village of Fraser Lake for their attendance to meetings has been amalgamated with the annual stipend. Members of Council will no longer be required to submit meeting allowance forms to receive compensation for meeting attendance. There will be no additional compensation for meeting attendance regardless of the number of meetings attended.

Travel Expenses:

Where members of Council wish to attend conferences, workshops or other venues considered beneficial to the community or developmental for the member of Council; Council's approval to incur expenses must be obtained.

Attendance to out-of-town meetings, conferences and workshops may require significant investment of time for travel. Members of council attending these meetings, conferences and workshops are eligible for daily meal allowances relative to the time spent traveling. Where travel and meeting attendance occur on the same day, the sum of time expended on both activities will be considered in the calculation of the daily meal allowance.

The Annual Renumeration Period begins:

The annual stipend paid to the Mayor and Council members authorized by this bylaw shall be retro- active to January 1, 2022.

Payment of Renumeration:

The annual stipend will be paid monthly in equal installments.

Partial Term of Office:

The annual stipend for Council members shall be prorated when the Council member does not hold office for the entire renumeration period.

Travel, Meal and Expense Allowance

Each year members of Municipal Council are provided a budgetary allocation for travel and expenses related to their attendance to conferences, workshops and out of town meetings that have been approved by Council.

This budgetary allocation follows the Village fiscal year: January 1st to December 31st.

- (i) To the Mayor, \$22,000.00 for the fiscal year beginning January 1st and ending December 31st.
- (ii) To the Councillors; \$6,000.00 for the fiscal year beginning January 1st and ending December 31st.

Repeal:

The Village of Fraser Lake Council Compensation and Allowance Bylaw No. 831,2022 is hereby repealed in its entirety.


