



**THE CORPORATION OF THE VILLAGE OF FRASER LAKE
TAX RATE BYLAW NO 840, 2023**

Being a bylaw for the levying of rates for Municipal, Hospital, Improvement District and Regional District taxation purposes for the year 2023


WHEREAS pursuant to the provisions of the *Community Charter* the Council shall, on or before the 15th of May in each year, adopt a Bylaw for imposing upon land and /or improvements, according to the assessed value thereof, a tax rate or rates for Municipal, Stuart-Nechako Regional Hospital District, and Regional District of Bulkley-Nechako.


NOW THEREFORE the council of the Village of Fraser Lake in open meeting assembles enacts as follows:

- 1) The following rates are hereby imposed and levied for the year 2023
 - a. For all lawful purposes of the Municipality on the assessed value of land and improvements taxable for General Municipal purposes rates appearing on Schedule "A" attached hereto and forming a part hereof.
 - b. For purposes of the Regional District of Bulkley-Nechako on the assessed value of the land and improvements taxable for Regional District purposes, rates appearing in Schedule "B" attached hereto and forming part of hereof.
 - c. For Hospital Purposes on the assessed value of land and improvements taxable for Regional Hospital District purposes, rates appearing in Schedule "C" attached hereto and forming a part hereof.
- 2) The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
- 3) This bylaw may be cited as the "Tax Rates Bylaw No 840, 2023."


